<p>UPON INITIAL RESPONSE AND MEETING WITH COMPLAINANT JOHN HAHN, OFFICER CLEARY AND DAMM DID ATTEMPT CONTACT WITH THE OCCUPANTS OF ROOM # 305. THERE WAS NO ANSWER WHEN OFFICER CLEARY KNOCKED AND ANNOUNCED HIMSELF AS A POLICE OFFICER. THE NIGHT AUDITOR GAINED ENTRY BUT NOONE WAS PRESENT. OCCUPANTS' BELONGINGS WERE STILL THERE. AT THIS TIME OFFICER CLEARY TELEPHONED ALLANA LIPPA VIA A TELEPHONE NUMBER PROVIDED BY MR. HAHN.</p> <p>OFFICER CLEARY LATER LOCATED AND TELEPHONED ANTHONY SCHIMIZZI, PHILLIP WATSON, KEITH CUMMINGS AND MATTHEW ABRAMS, THE YOUNG MEN SHARING ROOM # 601 AT THE BLUEWATER RESORT WITH PETER BROSWICK. THESE MEN REPORTED THAT THEY HAD FIRST MET BRITTANEE BRIEFLY AT CLUB KRYPTONITE ON FRIDAY NIGHT, 4/24/09, STATED THAT THEY DID NOT KNOW HER BUT THAT SHE WAS A FRIEND OF PETER BROSWICK'S FROM ROCHESTER, NY. LATE SATURDAY MORNING, 4/25/09, BETWEEN 11:00 AM AND 12:00 PM, MS. DREXEL IS REPORTED TO HAVE MET THEM ON THE BEACH FOR A SHORT TIME NEAR THE BLUEWATER RESORT AND THEN LEFT. WITNESSES ALSO REPORTED THAT BRITTANEE CAME BACK TO THEIR ROOM AT APPROXIMATELY 8:00 PM, BUT WAS ONLY THERE FOR ABOUT 10 MINUTES.</p> <p>PHIL WATSON AND KEITH CUMMINGS REPORTED THAT MS. DREXEL HAD BEEN ARGUING WITH HER FRIEND THAT SHE CAME WITH, THEY BELIEVE IT TO BE JEN (OBERER). MS. DREXEL WAS APPARENTLY WEARING MS. OBERER'S SHORTS AND MS. OBERER WANTED THEM BACK. BRITTANEE DREXEL IS REPORTED TO HAVE LEFT THE BLUEWATER RESORT TEN MINUTES AFTER ARRIVING TO WALK BACK TO THE BLUEWATER TO RETURN HER FRIEND'S CLOTHING.</p>
